Cr Dowler advised that the Chairman of the Motueka Community Board (Mr David Ogilvie) has requested a breakdown of the general operating expenses of the Motueka Aerodrome. Corporate Services Manager to be requested to provide this breakdown.

#### Port Tarakohe

Mr Frater advised that the income budget for the Port was distorted because it included expected income from the new marina that had yet to be built. Expenses for the Port were on target.
