1. OPENING AND WECOME

Acting Chief Executive, Mr D Bush-King, called the meeting to order and welcomed everyone to the Inaugural meeting of the Golden Bay Community Board.

He said it is the Council's wish to have a good working relationship with the Community Board over the next 3 years. He explained the Board's responsibility to represent the people of Golden Bay, to lead and serve the community in conjunction with Council staff. Mr Bush-King referred the Board to the Code of Conduct, the Local Government Act 2002 and the Local Government Official Information and Meetings Act 1987, the Crimes Act and other laws that the Board would be working under. He referred members to the Good Practise Guide that would help them.

Mr Bush-King said Council looks forward to working with the new Board and said that Council has appointed the Ward councillors to be members of the Board.

3. ELECTION OF CHAIRPERSON

Mr Bush-King called for nominations for the position of Chairperson of the Golden Bay Community Board.

Board member Gamby nominated C McLellan for the position of Chairperson of the Golden Bay Community Board; Board member Symmons seconded the nomination.

THAT nominations be closed and Board member McLellan be elected as Chairperson of the Golden Bay Community Board.

4. ELECTION OF DEPUTY CHAIRPERSON

The Chair called for nominations for the position of Deputy Chairperson of the Golden Bay Community Board.

Mr Bush-King referred the Board to the report from the Executive Officer – Strategic Development on the agenda regarding the Code of Conduct that has been amended and adopted by Council.

Board member Symmons commented that the Board appreciated Council's willingness to deal with issues that were raised by the Golden Bay Community Board.

The Chair drew attention to Appendix I Policy quality (Page 13 in old Code of Conduct) which has not been carried over to the new Code of Conduct; she had spoken with Acting CEO and believed there are enough checks and balances in the Local Government Act for this not to be carried over to the new Code.

7. APPOINTMENT OF REPRESENTATIVES TO VARIOUS COUNCIL AND COMMUNITY COMMITTEES

The Chair pointed out that Board members had agreed to their portfolios at a previous workshop.

Mr Bush-King commented that there is no Resource Management Committee now – it is the Environment & Planning Committee.
