1 PUBLIC FORUM

1.1 L Harvey, Motueka Pool Committee

Mrs Harvey said the Motueka Swimming Pool Committee has set up a website www.motuekapool.org.nz and they are gathering signatures to put forward a petition to Council for funding from the \$12.5 million share buy-back to build a pool in Motueka.

1.2 F Hickling, Motueka Pool Committee

Mr Hickling spoke in support of a pool for Motueka and asked that it be kept in the Long Term Council Community Plan. He asked the Community Board to support them in their endeavours.

1.3 J Butler

Mr Butler said Mr Cooke was unable to attend the meeting tonight and asked that a rubbish bin and doggy-do dispenser be placed by the Inlet Walkway.

Mr Butler expressed concern at the cost of sealing the car park at the Saltwater Baths.

1.4 M Lafrentz, Kiyosato Gardens, Deck's Reserve

Mrs Lafrentz said a Tea House had been planned for the Kiyosato Gardens and she requested the Community Board support the construction of it. She tabled a photograph of the Tea House at Myiazu Gardens in Nelson

1.5 S Horrell, Kiyosato Gardens, Deck's Reserve

Mrs Horrell asked that the Tea House be built at Kiyosato Gardens to complete the project.

1.6 M Nicholls

Mrs Nicholls said the Motueka Arts Council had noted that the rope has been removed from the streetscaping in High Street. They preferred that rope be used for replacement, rather than chain for safety reasons.

Mrs Nichols said the Arts Council would come back to the Board and Steve Elkington with a price for the replacement of the rope etc.

2. DILs

Community Services Manager, L L Kennedy, was in attendance and tabled a report of projects included in the LTCCP for the Motueka Reserve Development Impact Levies, with revised projects included. It is estimated the opening balance for the 2007/2008 year will be \$200,000, rather than the \$100,628 estimated. \$30,000 has been included for the Tea House at Deck's Reserve.

Mr Dowler asked if a boundary fence could be built along the boundaries of the new houses by the netball courts.

Mr Kennedy said the landowners need to approach Council and fencing would be done on a cost-share basis.

Mr Kennedy suggested putting \$5,000 in the budget for the next three years under Picnic Areas, Marahau Foreshore.

Mr Dowler commented about the problems at Memorial Hall with heat.
