#### 1 PUBLIC FORUM

#### 1.1 Ted Krammer

Mrs Stewart asked that the name St Arnaud be retained. She said the Rotoiti District Community Council survey was flawed and gave the impression that St Arnaud had only been called St Arnaud for a short time.

Mr Higgins said the case for change of name for St Arnaud has gone to the Geographic Board. He suggested the opponents to the name change should put their case to the Geographic Board.
