HOSPITAL WINS TOP NATIONAL AWARD

The Awards were announced on Saturday 13 March 2010 at the 2009 TrustPower National Community Awards Dinner, held at the World of Wearable Arts and Classic Cars Museum (WOW) in Nelson.

The Runner-Up was the Katikati Open-Air Art, representing the Western Bay of Plenty District.

The 25 teams participating in the Awards each gave an eight minute presentation on their activities or project in a judging session held at the Nelson School of Music. The teams were judged on that presentation

and on a 1,000 word summary each group provided prior to the event.

The Friends of Motueka Hospital Trust was represented by Jack and John Inglis, along with Tasman Mayor Richard Kempthorne and his wife Jane and Nelson City Mayor Kerry Marshall and Nelson City Councillor Gail Collingwood.

TrustPower Community Relations Manager Graeme Purches says the Friends of Motueka Hospital Trust are an inspiration to all New Zealand communities who are seeking to improve their local health services. The Awards were filmed by a TVNZ 6 crew, who will be profiling the Supreme Winner and Runner Up through a new series called Volunteer Power, to screen on TVNZ 6 in late May.

TRUST GIVES REC CENTRE A BOOST

A \$100,000 donation from the Canterbury Community Trust has given the Motueka Recreation Centre more room to breathe, says regional centres manager Brent Maru.

The centre is in the midst of a \$2 million revamp, courtesy of Tasman District Council, but the wishlist had to be pared hard to stay within a "sharp" tender for the job, says Brent. Thanks to the trust, "we can now put that key stuff back in."

The centre caters for the whole community, from preschoolers to the elderly. Youth groups even travel from Golden Bay to use it. After the refurbishment – removing the last vestiges of the building's past as a fruit

packhouse – the multi-use centre will spread its wings further. A new wooden floor caters for roller hockey and the growing sport of roller derby – a stockcar race on tiny wheels, says Brent.

Netball and soccer will have more courts to use when paddocks become unplayable in winter. Badminton and basketball are set to benefit, as will all fitness classes, which bring vital revenue into the facility. Afterschool programmes, dance classes and functions also use the centre.

Brent says new changing facilities will banish the aura of an old-school rugby clubroom.

The Motueka centre, which also houses a multiplex cinema, must be the most diverse in the region, he adds. Centre staff even venture out for activities at schools and kindergartens, to reach as many youngsters as possible.

FUTURE MANAGEMENT OF WAIMEA INLET IN FOCUS

The Waimea Inlet, that for many has now become a highlight of the drive to and from Nelson, is one of the truly unique natural features of our region.

For others it represents an estuarine habitat that is home to many birds, fish and magnificent plants and should be protected and enhanced. It is also of historical significance to early Maori and European settlers as a food source and the site of the first public transport venture in Nelson.

At the very least, residents of, and visitors to, the region should be given the opportunity to appreciate the beauty and significant natural values on their back door.

To this end, Tasman District Council and Nelson City Council have jointly initiated a project about the future management of Waimea Inlet and land adjoining it. The Councils want to know what you want the inlet and land around it to be like, how you want to be able to use the area, and which parts should be left alone or helped to re-establish how they were.

Three key strands are:

- The inlet and its margins have significant natural values, especially birdlife, vegetation, and landscape;
- The inlet is bordered by land that is used for residential, lifestyle, rural production, business and industrial purposes, as well as by major roads;
- The inlet and its margins have potential for a range of recreational, sport and social activities.

The intention of the project is to combine people's aspirations for the future of the inlet into a management strategy that is supported by the community and the two councils.

There are two scheduled events that you can participate in:

 A technical workshop on 23 April 2010, from 9.30 am to 5.00 pm, at Greenacres Golf club where there will be presentations and discussion about ecological, historical, and recreational values of the inlet, and water quality.



 A public meeting on 19 May 2010, from 7.00 pm to 10.00 pm, (venue to be confirmed), where the emphasis will be on smallgroup discussions and suggestions from participants, rather than formal presentations.

As prompts, you could consider these questions:

- What is special to you about the Waimea Inlet and the adjoining land?
- What do you want the inlet and adjoining land to be like in the next ten years or more?
- · What needs to be done to achieve what you want for the inlet? You are also encouraged to talk about the future of the inlet with friends, neighbours, or other contacts you have with landowners, businesses or recreational users with interests related to the inlet, and let us know the results. This could cover matters such as:
- How the inlet can gain additional focus for the Nelson-Richmond-Waimea-Mapua parts of the region.
- Extending the habitat needed by the birdlife for which the inlet is "home", including the species that migrate to and from the northern hemisphere.
- How public access to and around the inlet can be achieved while respecting the birdlife, indigenous vegetation sequences, and the rights and aspirations of adjoining landowners.

ARE YOU CONCERNED ABOUT FLOODING IN MOTUEKA?

The Tasman District Council's Ten Year Plan identified the need for a review of the current flood control measures for Motueka.

Investigations have shown the current engineering fitness of the Motueka Stopbanks would not hold up under any degree of severe flooding and are unlikely to adequately protect the local residents and their assets.

The current flood control and stopbanks were discussed at length by submitters during the Plan's consultation processes. While many submitters acknowledged the need to have the project continue, it was on the condition that adequate on-going public consultation was an integral part of the process, at least to the detailed planning stage.

At the heart of the conditional agreement by the community was the need to identify what risks were posed by the current state of affairs; what is an acceptable level of risk and what is the community prepared to pay for?

To reach an appropriate outcome the concerns and risks identified by the community of Motueka will be analysed, possible options identified and an evaluation of these options will be undertaken.

By developing a range of solutions, each with their own risks attached, interested people will be able to gain a basic understanding of the sort of operational outcomes eventually adopted as the most acceptable solution.

Feedback provided by the public as part of the Ten Year Plan indicates that a range of options and their merits and drawbacks will be welcomed by the community.

Discussions with the community and identifying the risks and concerns that exist in relation to flooding has begun.

There are no pre-determined answers or solutions at this time, your concerns will feed into the process of understanding what possible solutions may work.

Please take the opportunity to tell us your concerns – you can do this in a number of ways, by coming and talking to us at the feedback forums, the Sunday market or write to: The Motueka Flood Control

There have been two consultation meetings held already; the first with immediately affected landowners on the banks of the Motueka River and the second with identified industry and rural groups in the area.

Tasman District Council released its Draft Annual Plan 2010/2011 for public consultation on Monday 22 March 2010.

The Draft Annual Plan covers the year from 1 July 2010 to 30 June 2011.

The purpose of the Draft Annual Plan is to get feedback on whether you think Council is planning to provide the right services and activities within the Tasman District. Your views will help guide Council's decision-making, prior to the final plan being adopted in June 2010.

Council approved the Draft Annual Plan for public consultation at its meeting on 12 March 2010.

The Draft Annual Plan comprises two documents:

- A Summary, which was sent to all households in the Tasman
 District through a special edition of Newsline on 19 March 2010.
- The Draft Annual Plan containing the key changes Council is planning from the proposals in the Ten Year Plan for the 2010/2011 year, the services Council is planning to provide, the costs of the services and how the services will be funded.



TASMAN REGION HIGHLIGHTED AS A CLEAN STREAMS ACCORD LEADER

The release of the 2008/2009 Dairying and Clean Streams Accord Snapshot report shows that the management of dairying effluent is still a subject demanding close attention nationally.

The District Council, farmers and their representative bodies in the Tasman region are working hard and taking the lead to improve the management of waste on their farms. The Aorere and the Sherry Catchment groups have national recognition for their efforts to tackle the issues.

"The likes of the Aorere Catchment Group's work on farm plans, and their farmer-led effluent workshops, are setting our region in a good light and is all about industry taking the lead" says Tasman Mayor Richard Kempthorne.

In getting alongside the dairy sector the Tasman District Council remains committed to the Accord as it has been proven to

bring benefits to the farmers and other users, recreational and commercial, of the environment.

As well as maintaining a consistent approach to farm monitoring the Council has provided incentives through a fencing subsidy, aiding the exclusion of stock from water ways, and the freeing up of some conditions around single-span stock crossings.

"In light of the good work we are doing together it is disappointing that a small number who do not take their responsibilities seriously detract from the goodwill responsible farmers are building up in their local communities. Working with the sector the Council will continue monitoring farms as the two recent prosecutions in the Environment Court taken by the Council demonstrate".

"We have achieved our acknowledgement as one of the more successful Councils because of the supportive attitude for the accord by the majority of the farmers in our district and we thank and applaud them for that, as do their communities," said Mr Kempthorne.


ARE YOU UP TO THE CHALLENGE?

residents are being challenged to ONLY eat and drink produce that's been grown, baked, made or produced within the Top of the South. So if you can grow it, make it, freeze it, swap it or buy it from a local grower or supplier, you'll be on the right track.

There are some awesome prizes available for the top two Eco Challengers: A Nelson prize of \$500 in vouchers from FreshChoice Nelson City, \$250 in vouchers from Bunnings, and a \$50 Christmas present from New Zealand Credit Union (NZCU); and a Tasman prize of \$500 in vouchers from FreshChoice Richmond, \$250 in vouchers from Bunnings, and a \$50 Christmas present from NZCU. Other smaller rewards will be awarded to highly commended Eco Challengers.

THREE DRAFT AMENDMENTS TO THE TASMAN RESOURCE MANAGEMENT PLAN

The Council is requesting comment on the following draft Resource Management Plan amendments (two changes and one variation):

- · Richmond East Development Area
- · Active Fault Rupture Risk Management, and
- Review of the Slope Instability Risk Area, Richmond

Richmond East Development Area

The draft plan change for the Richmond East Development Area follows on from consideration by Council of the consultation feedback received on the Nelson South - Richmond East draft Structure Plan report. This report was released jointly by Nelson City and Tasman District Councils for public comment in March 2008.

The Richmond East Development Area is the land situated on the eastern margins of Richmond, south west of Champion Road, from Salisbury Road in the north to the rural hill slope land located to the south east of Richmond. The development area forms part of the Nelson South – Richmond East precinct which spans both Nelson City and Tasman District. The Nelson City and Tasman District Councils are planning the development of this area together.

The draft plan change forms part of a long-term strategic approach to provide for the residential growth of Richmond commenced through the Richmond Development Study in 2003. It provides for part expansion and part intensification of a high amenity residential environment in Richmond East by utilising the area efficiently for residential development while retaining and providing for a quality urban environment. Specific residential densities are proposed for specific areas within Richmond East, depending on their location and character. The larger allotment size, south east of Hill Street, is a means of retaining the character of the existing residential environment while enabling a measure of intensification.

The landscape value of the hills behind Richmond East and Nelson South is being retained by limiting development to the lower hill slopes and providing for lower density residential development at the interface with the rural land.

The draft plan change proposes a connected network of streets, walking and cycling routes that cross and connect the area with the rest of Richmond and Nelson South, particularly the proposed Saxton Creek greenway and Saxton Fields sports complex.

The draft plan change provides for the protection of 29 newly listed trees, (including four groups of trees) for the purpose of maintaining a quality environment and retaining the valued character of the existing environment while providing efficiently for residential development.

- Active Fault Rupture Risk Management
- Review of the Slope Instability Risk Area in Richmond

Council is also requesting comment on two draft amendments updating the Tasman Resource Management Plan 'Active Fault Rupture Risk Management' and 'Slope Instability Risk' Area provisions.

These draft amendments contain technical changes that are relevant to the Richmond East location.

The draft change to Active Fault Rupture Risk Management Plan provisions proposes to introduce an amended position for a corridor of land along active faults, called the 'Fault Rupture Risk Area', along the Richmond foothills from Champion Road in the northeast, to Haycock Road and the hills behind it in the southwest, as well as land in and to the east of St Arnaud.

Elsewhere in the District, in a number of locations in the upper Buller catchment, the active faultline is largely unchanged in position but replaced by the Fault Rupture Risk Area; and some faults are no longer shown as active.

The rules have been rewritten (Section 18.13) and regulate subdivision and building development by requiring a range of setbacks from the position of the active fault where it is located by a specialist geological or engineering report.

The draft amendments to the Slope Instability Risk Area are an extension of this special area along the Richmond foothills, together with some minor technical amendments to rules applying in the Area in Section 18.12 of the Plan.

DISTRICT-WIDE MAJOR PROJECTS FOR 2010/2011

During 2010/2011 we are proposing to provide the following new facilities, activities and services on a district-wide basis:

Environment and Planning:

- Complete Part IV of the Tasman Resource Management Plan
 Rivers and Lakes.
- · Investigate the merger of the Tasman Regional Policy Statement with the Tasman Resource Management Plan.
- Review and administer the Regional Pest Management Strategy in conjunction with Nelson City Council.
- Review issues and options for managing activities and impacts on the Waimea Estuary in conjunction with Nelson City Council, Department of Conservation, Iwi and stakeholders.
- Revise and continue implementing the State of the Environment Monitoring and Reporting Strategy.
- Review and implement the Nelson Tasman Civil Defence Emergency Management Plan.

Engineering:

 Ongoing development of new kerb and channel, pram crossings and footpath construction district wide.

Community Services:

- Upgrade township entrance signage and amenity planting around the district.
- Upgrade Treasured Pathway signage and improve promotion of the Pathway.
- Enhancing recreational opportunities at Waimea River Park and Rabbit Island.
- ASB Aquatic Centre new learners pool to be completed in 2010/2011.

- Funding towards continued development at Saxton Field and the Motorsport Park.
- Completion of the Youth and Halls strategies started in 2009/2010.
- Funding for new playgrounds as reserves are developed and for the replacement of aging play equipment.



Golden Bay Ward major projects for 2010/2011

The Golden Bay Ward includes the settlements of Takaka, Pohara / Ligar Bay / Tata Beach / Tarakohe, and Collingwood.

Major projects proposed for the Takaka settlement area

Environment and Planning:

- · Strategic development planning for Eastern Golden Bay.
- Review water management provisions for the Takaka Water Management Zone.

Engineering:

- · Re-seal Cobb Valley (lower road).
- · Takaka fire fighting water supply.
- · Takaka wastewater treatment plant upgrade.
- Design work for stormwater reticulation improvements in parts of Patons Rock (construction work to be undertaken in subsequent years).

Community Services:

- · Golden Bay school pool upgrade (location yet to be determined).
- Funding to upgrade the facilities and for tree planting at Golden Bay Recreation Park.



- · Construct public conveniences at Labyrinth Rock Park.
- · Develop natural burial area at Rototai Cemetery.
- Funding for parks and reserves walkways/cycleways.
- · Upgrading some of the old small wharves.

Major projects proposed for the Pohara / Ligar Bay / Tata Beach / Tarakohe

Environment and Planning:

· Strategic development planning for Eastern Golden Bay.

Engineering:

- · Cycleway Abel Tasman Drive, Takaka to Pohara 2010 2018.
- Renewal of Awaroa Bridge No. 1, Awaroa Road (subject to funding confirmation).
- Port Tarakohe at Golden Bay, marina and wharf replacement
 design and feasibility, with construction to follow in subsequent years.
- · Pohara / Tata Beach land purchase for and upgrade of wastewater pump station and upgrade gravity main.
- Stormwater reticulation improvements in parts of Pohara 2010
 2012.

Community Services:

- Continue to support all coastcare projects including those running at Tata Beach, Ligar Bay and Pohara.
- Develop interpretation panels outlining the environmental values along with bird and coast care information for the coastal estuary reserves.

Major projects proposed for the Collingwood settlement area

 Western Golden Bay Strategic Development Study in response to settling appeals on landscape matters.

Engineering:

 Renewal of Yellowpine Creek Bridge on Pakawau-Bush road (subject to funding confirmation).

Community Services:

- Continue to support the Coastcare projects running at Collingwood and Pakawau.
- Develop interpretation panels outlining the environmental values along with bird and coast care information for the coastal estuary reserves.

LAKES-MURCHISON WARD MAJOR PROJECTS FOR 2010/2011

The Lakes - Murchison Ward comprises the settlements of Murchison, St Arnaud and Tapawera.

Major projects proposed for the Murchison settlement area

- · Hotham Street wastewater pump station upgrade.

- · Funding for parks and reserves walkways/cycleways.
- · Redevelopment of the shrubbery at Murchison playground.

· Develop the carpark at Rotoiti Community Hall.

Major projects proposed for the Tapawera settlement area

DOG-WALKING SIGNS DESTROYED

Vandals destroying the dog-walking signs at Tata Beach in Golden Bay could be bitten quite painfully by the law.

"We will look at what sort of legal redress we can pursue through the police," says Graham Caradus, regulatory services co-ordinator at the Tasman District Council.

The offence of wilful damage carries a maximum fine of \$2000 or up to three months in jail.

Graham says the vandalism is costly in staff time to organise replacement signs and have them installed. Council has switched from wooden to stick-on signs because of the problem.

He says the Tata Beach area has a history of damage to signs going back years, but the vandalism has flared since new signs went in before last Christmas on rubbish bins and doggie-do bag dispensers.

"People are simply stripping them off the bins."

Council can only speculate about motive, whether it is dog-owners upset at restrictions, or beach-users angry that dogs are allowed at all.

Because of the fragile birdlife at Tata Beach, dogs are banned completely during the period of Daylight Saving Time, and for the rest of the year dogs are banned for the period one hour either side of

Graham says the vandalism is Bay-wide. On one occasion he put up a dozen signs between Takaka and Puponga, "and on the way back 10 had been removed".

WHAT MAKES A GOOD WOOD SUPPLIER?

Good Wood – we all know that we should burn it, but what actually is it and where can we get it? How do you know if your wood is 'good'?

Good wood is untreated, seasoned (not green), and dry, with a moisture content of less than 20%. It is illegal to burn treated wood or wood with a moisture content of more than 25%.

Tasman District Council and Nelson City Council sponsor a good wood scheme to encourage people to sell, buy, and burn good wood. To be a good wood merchant, suppliers must guarantee to supply to the

public either dry seasoned firewood suitable for immediate use, or green (unseasoned) firewood delivered sufficiently far in advance of winter so that, if properly stored by the user, the wood will be seasoned for use the following winter.

They must also ensure that the customer is fully informed if unseasoned or wet wood is supplied, and have a moisture meter available to measure moisture content of any piece of firewood if the customer requests it. Good wood suppliers will never supply treated timber.

Good wood suppliers however, cannot guarantee that they will have dry wood, available for immediate delivery, in the middle or near the end of a long rainy winter.


Rob Francis, Environmental Educator

at Tasman District Council explains, "Wood merchants have limited

undercover storage so it's important that customers play their part too, by ordering more wood when they have used half their stack, so that if only rain-wet wood is available it has time to dry out before use. Buying your wood now helps also, because it clears out the wood merchants' yards and allows them to stockpile more wood to dry out for the winter months."

Part IV: Rivers and Lakes and

Consequential Amendments to Parts I & II, V and VI

Public notice is given pursuant to Clause 5 of the First Schedule of the Resource Management Act 1991 that the Tasman District Council has prepared amendments to the Proposed Tasman Resource Management Plan, known as Proposed Variations 68 – 70 and Proposed Change 17.

Variation 68 - Part IV: Rivers and Lakes

Proposed Variation 68 introduces Part IV to the Tasman Resource Management Plan dealing with the management of adverse effects of activities in the beds and on the surfaces of rivers and lakes.

Change 17 and Variations 69 & 70 – Consequential amendments to Parts I, II, V and VI arising from Part IV (Rivers and Lakes)

The following documents amend the Plan to ensure consistency and integration with issues addressed in Part IV:

Change 17 – Amends Parts I and II, Variation 69 – Amends Part V, Variation 70 – Amends Part VI **Submissions**

Any person may make a submission on any part of the proposed variations and change. Submissions need to be in writing, and must clearly indicate support or opposition to the provisions. They must also state the decision that the submitter wishes the Council to make, with reasons, and whether or not the submitter wishes to be heard in support of his or her submission. The submission must also provide an address for service. Forms for making submissions are available as indicated below under "Availability of Proposed Change/Variations". Submissions can be sent to the Manager Policy, Tasman District Council, Private Bag 4, Richmond 7050 to be received by **4.00 pm on Monday**, **26 April 2010**.

Consideration of Proposed Change/Variations

After submissions have closed, Council will publish a summary of all decisions requested by submitters. There will be a further period of 10 working days within which further submissions in support or opposition to those made may be sent to Council. Council will then hear submissions and make decisions on the Plan Variations and Change. Any submitter who is not satisfied with Council's decisions will have a right of appeal to the Environment Court.
