# From Golden Bay Community Board meeting – October 2011

## Chairs Report -

The names of Pupu Valley Road and Pupu Springs Road need to be discussed with the community prior to any changes of the names to Te Waikoropupu Valley and Te Waikoropupu Springs roads.

The Department of Conservation has recently gazetted the full Maori name of Te Waikoropupu Springs (Pupu Springs) Reserve. As a result they have requested that Tasman District Council considers changing the road names for Pupu Valley Road and Pupu Springs Road.

Tasman District Council staff has prepared a report and is seeking feedback from the community with regard to changing these adjacent roads' names. (Attached to this report).

# Recommendation:

"That the Golden Bay Community Board consults with the affected landowners and community members regarding name changes from Pupu Valley Road (to Te Waikoropupu Valley Road) and Pupu Springs Road (to Te Waikoropupu Springs Road). Further, that the Golden Bay Community Board sets a date to hold a public meeting to consult with the community on the proposed renaming of these roads."

Following discussion regarding the consultation and whether the Board should make a recommendation to Council regarding the results, it was pointed out that the Department of Conservation had asked for the change of name to be consistent with the Te Waikoropupu Springs name, and it was AGREED that the matter lay on the table and further information be sought regarding the Pupu Valley Road.

## 7.1 Consultation on the Proposal to change Pupu Springs Road and Pupu Valley Road to Te Waikoropupu Springs Road and Te Waikoropupu Valley Road

It was agreed that the suggested resolution (below) lie on the table until Board member Symmons reports back to Manawhenua, and that a letter be sent to Engineering Services to tell them what is happening, and that the matter comes back to the March meeting.

"THAT in view of the feedback received the Golden Bay Community Board recommends to Engineering Services that the names Te Waikoropupu Springs Road and Te Waikoropupu Valley Road be used on signage in addition to Pupu for both the springs road and valley road."

THAT until consultation is complete with Manawhenua ki Mohua the resolution regarding the Pupu Springs Road name change will lie on the table until the April meeting of the Golden Bay Community Board. CARRIED

It was agreed that Board member Symmons take the Board's recommendation to Manawhenua ki Mohua.

The Chair commented that the Board has completed its consultation with the residents of Pupu Valley Road and had a comprehensive response; the residents do not want their road name changed.
