Reasons for my Submission and Objection.

### 1. Construction of Earthworks that may result in diversion of flood waters.

Because there is a gradual slope from the Motueka River at Woodman s corner to the sea, any bund or obstruction to the flow of water during heavy rain events will divert extra surface water onto neighbouring properties which could cause inconvenience or damage. I remember being amazed at the volume of surface water flowing down Green Lane during heavy rain and therefore know that any impediment to the flow of surface water could cause serious problems.

### 2. Construction of buildings which breach the airport height controls.

Because Ruru Buildings Ltd activity will protrude above the 1.5 Height Control Restrictions they are asking TDC to increase the Height Restrictions to allow them to construct buildings.

I oppose any building or activity on this property that breach Height Restrictions or impact the viability of the Motueka Airport to operate in a safe and economic way.

Point 2. is by far my main objection. The Motueka Airport has been there for approximately 100 years and when the Applicant bought the land at 54 Green Lane the restrictions would have been flagged on the Title. The Height Restrictions are there for a purpose for the safety of those using the Airport Runway. To breach these jeopardizes not only the safety but also the viability of Airport users. Extreme weather events as experienced in Hawke's Bay recently, shows the importance of large aircraft such as DC3 being able to use the Airport during emergency.

The bottom line is that the Motueka Airport has been there for 100 years and because of its location and Motueka climate, it is not only an ideal place for a Flying College, but because of location and climate, it is ranked as one of the top Skydiving places in the World. The income and activities generated by the Aviation College, Argus Aviation and the Skydiving operations alone are a huge asset to Motueka and put us on the World Map. They also employ a good number of highly qualified staff,

It would be impossible today to shift the Motueka Airport or alter its flight path, whereas Ruru Buildings Ltd have many options open to them.

I therefore oppose any restrictions or impact that may occur on the Motueka Airport operations, because of the Application of Ruru Buildings Ltd.

Submission for opposition to Ruru Building Ltd, Resource Consent Applications RM210785, RM210786, RM220974.

To whom it may concern,

Argus Aviation Ltd wishes to oppose the above referenced Resource Consent Applications by Ruru Building Ltd for the following reasons:

1. Aviation and Public Safety:

As a New Zealand Civil Aviation Authority Approved Part 145 Maintenance Organisation we are required by regulation, to have an approved Safety Management System. Both of these approvals require regular review of our complete operation by the New Zealand Civil Aviation Authority, alongside a process of continuous improvement.

It has been identified under our Safety Management System that a reduction of usable runway length & potential encroachments on the 1:50 OLS at Motueka Aerodrome, would present a hazard to aircraft types we service and utilise ourselves in our daily business. This would lead to an increased risk factor for these operations and potentially impact aircraft customers into our Motueka base. For example, any further decrease in operational length of the runway / OLS would limit us to maintenance of lower performance 4 seat (and less) type aircraft and prevent us from servicing our current 6 seat and above general aviation aircraft, along with twin engine aircraft and higher performance aircraft.

As the Tasman District Council is the operator / land owner for the Aerodrome, under the Health and Safety Act (2015), an organisation conducting a business or undertaking (PCBU) they are required to eliminate risk as much as practically possible, within applicable controls.

This application to construct a structure directly underneath the flight path of the runway, with intrusion into the current OLS, presents a serious Health and Safety Risk to every airport user, alongside employees / contractors of Ruru Buildings Ltd. Should an aircraft have an engine failure on take-off or stall on landing finals, then a very real risk presents itself of serious injury or death within the Green Lane property and for the occupants of the aircraft. It should be noted that there have been previous events of aircraft having engine failures on take-off from Motueka, which have luckily resulted in being non fatality incidents.

As Motueka Aerodrome is a long established Pilot Training Aerodrome it is imperative that every advantage is given to these pilots who are learning from an Ab-initio level. More runway and more areas available, should an unlikely incident occur is a benefit to both the aircraft operators and the public interest.

#### 2. Strategic Asset:

Motueka Aerodrome is a strategic asset to the Tasman region and the greater area. Quite simply, it was air support that was first on the scene and providing support / rescue / supply drops to Gisborne / Hawkes Bay following the recent Cyclone Gabrielle. This was provided by Helicopters and Aircraft that utilised all of the available Aerodromes in the region.

In the case of Motueka Aerodrome, it provided relief and a point of operation when Cyclone Gita impacted the Tasman region in February 2018. This cyclone closed the Takaka Hill road and numerous trips were run out of the Aerodrome in support of moving both people and supplies. As climate change is upon us, it would appear that these weather events are becoming more frequent and the strategic asset value of the Aerodrome is only increasing for support of the regional populous in these type of events.

In the event of a major incident / emergency, Motueka Aerodrome can be used by a range of RNZAF Aircraft up to a C-130 Transport Aircraft. It is imperative that this capacity can be retained for the community in its time of need and not be reduced by the implications of runway length and OLS heights that this application presents.

#### 3. Community Asset:

Motueka Aerodrome is an often undervalued asset of the local community and only in times of need ,does it's relevance come to the forefront. Should the proposed Resource Consent be approved, it will cause the following;

- Limitations of size / type of aircraft that can assist the local community in times of need.
- Decreased use as an alternate aerodrome for both Nelson & Karamea Aerodrome for certain types of aircraft. Use of alternate aerodromes is required during emergencies / bad weather / runway closures following aircraft incident etc.
- Decreased direct employment in the area of specialised aviation based roles from Advanced Pilot Instructors through to specialised Aircraft Engineering services.

#### 4. Previous non-compliance:

Ruru Building Ltd has established a precedence of non-compliance with Aviation Safety and the current rules / restrictions on the land use.

- Ruru Buildings Ltd knowingly erected a mobile crane on site, directly under the northern end of the active runway, without prior approval or notice to Airmen. This incident occurred in October 2021 as was the subject of an Aviation Related Concern investigation by the Civil Aviation Authority. It should be noted that this occurred following advice by the Tasman District Council officer, who administrates the aerodrome facility to not proceed and direct notification to the contracted crane company.

 Ruru Building Ltd has currently constructed a structure on this Rural 1 land which contravenes the restrictions on Rural 1 land and we believe without appropriate consents.

 Ruru Buildings Ltd has been conducting an industrial activity on the subject site, since purchase of the land, in contradiction to the current restrictions of Rural 1 Land. In addition, it would appear commercial activities are being conducted on site and include Site Open Days (December 2022) and being able to book consultations and view show homes on site via Ruru Homes website. This would contravene the details provided in Ruru Building Ltd – Application for Resource Consent Document – dated August 2021.

5. Direct effects on local established businesses at Motueka Aerodrome:

Nelson Aviation College – A long established Aviation Training Organisation in Motueka that has trained a large number of both fixed wing and helicopter pilots from inception. Nelson Aviation College is a recognised Air New Zealand feeder school for pilots and held in high regard nationwide. This consent will directly affect the safety of their operation and also impede future training needs. Currently New Zealand and the world have a critical shortage of commercial pilots for current openings and future growth.

Skydive Able Tasman Ltd – A long established tourism / adventure business in Motueka. OLS intrusion and a decrease in operational length of the runway will no doubt cause change of aircraft type to a smaller airframe. This is will result in further flights, noise profile and cost to meet the requirements of their operation.

Golden Bay Air Ltd – An established Part 135 Air Transport operator based in Golden Bay, who provide flights into & out of Motueka as required. Limitations on runway length and OLS will directly affect their operation and services will decrease. Equally, Motueka Airport is used as an emergency alternate airport for this operation.

Argus Aviation Ltd – An established Part 145 Maintenance Organisation that maintains 60 aircraft between Motueka and Taupo. A restriction on the use of Motueka airport would directly affect our business and the ability to service / maintain the larger aircraft types and high performance aircraft. We regularly employ local based apprentices for the Helicopter / Aircraft industry and provide a placement service for training with the Nelson Marlborough Institute of Technology.

Tasman District Council (As Aerodrome Operators) – Decreased demand for potential future hangar sites due to an inability to cater for large type aircraft, if there are runway limitations. This would directly impact future investment into the airport and revenue that can be generated from the facility.

Future businesses – This must be considered for Motueka Aerodrome. Should limitations be imposed, the airport will not be able to cater for larger tourism type flights, regular public transport flights and new company start-ups.

For the reasons above, Argus Aviation Ltd opposes the application for resource consent. We also request the opportunity to be heard at the hearing to discuss all aspects of this submission.

Name of Submitter: Tasman District Council as owner and operator of the Motueka Aerodrome (**the Motueka Aerodrome**).

- 1. This is a submission from the Motueka Aerodrome (**the submitter**) on a resource consent application by Ruru Building Ltd (**the applicant**) an existing industrial activity (and to enable its expansion) within a Rural 1 Zone at 54 Green Lane, Motueka.
- 2. Resource consent is sought as follows:
  - Section 9, land use, to undertake an industrial activity which is a construction of relocatable homes;
  - Section 9, land use, construction of buildings within the setback and exceeding building coverage;
  - Section 9, land use, construction of more than one vehicle access;
  - Section 9, land use, construction of a building which reaches the height allowance within the obstacle surface limitation area (**OLS**);
  - Section 15, discharge permit, discharge of domestic wastewater exceeding 2,000 litres per day;
  - NESCS, change of use, change of use of productive land to industrial activity.
- 3. The Motueka Aerodrome opposes the application.
- 4. The Motueka Aerodrome is not a trade competitor for the purposes of s 308B of the Resource Management Act 1991 (**RMA**). Its submission relates to the resource consent application as a land use activity. In particular, the submitter has concerns about the construction of buildings and potential landscaping which do not comply with Rule 16.11.2.1 (Schedule 16.11A) and the introduction of an industrial activity in close proximity to the aerodrome.
- 5. The submitter considers that the proposed activity is fundamentally incompatible in the current locality given its close proximity to the centre point of the runway, that it will introduce unacceptable risk to the health and safety of aircraft using the runway and the people working at the subject site. In addition

it has the potential to significantly undermine the use of the runway as significant regional transport infrastructure, with the potential to impact on the wider region.

6. The submitter therefore seeks that the application be declined.

### The Aerodrome

7. The aerodrome is owned and managed by the Council. The aerodrome has been in existence since 1934. The Council owns Lot 1 & 2 DP 18903 which is identified in yellow in the map below:



- The aerodrome is designated (D09) in the Tasman Resource Management Plan (TRMP) as an aerodrome containing a land parcel of 30.3875 hectares. The Council is the requiring authority for the designation.
- 9. The aerodrome has a runway which serves a wide range of aircraft: Cessna, Pilatus, Piper, Classic Aviation Adventurer and varying types of helicopters. There are also a range of businesses located on the designated site. These businesses include Nelson Aviation College, Inflite Experiences, and Argus Aviation Limited. The Motueka Aero Club also operates and is active on the airfield.
- 10. In particular, Nelson Aviation College operates from the Aerodrome. The College operates a college for the training of pilots. It is estimated that pilot training forms approximately 74% proportion of aircraft activity at the Aerodrome. In the last 12 months there were 20,840 aircraft movements from the aerodrome, of which 15,506 were operated by the College.
- 11. Inflite Experiences have operated from Motueka since 1991, with it becoming their permanent base of operations in 2000. Pre Covid numbers saw annual flights at approximately 1500 with approximately 10,000 jumpers per annum. The business is currently running at about 60% of the pre-covid numbers.
- 12. The aerodrome also forms significant regional transport infrastructure. There are limited airports and/or aerodromes in the Tasman and Nelson Regions, only those located at Nelson, Takaka and Motueka. The Nelson airport is located close to the coastline and therefore may be subject to seawater inundation and sea level rise. Nelson Airport is also in the path of a tsunami as per Nelson Tasman Civil Defence Tsunami Maps. Therefore, Motueka Aerodrome acts as a vital regional resilience aerodrome. The aerodrome is also used for Civil Defence purposes.

### Motueka Aerodrome's submission

### Incompatible Land Use

13. The proposed site is approximately 79 metres to the northeast end of the boundary of the aerodrome from the southwest corner of proposed site. It is also located in the centreline of the runway in that aircraft approach the

aerodrome from this direction (over the subject site) or take off from this direction (depending on the prevailing wind).

- 14. The proposal is for an industrial activity involving the construction of buildings including up to 60 staff members working from the site. Cranes are necessary to shift the relocatable buildings onto trucks.
- 15. The location of this activity within such close proximity to the centreline of the runway is incompatible in terms of both the number of people introduced into this area and the need to ensure there are no obstacles which could present an obstacle to aircraft taking off or landing and also affect wind flow (the presence of buildings has the potential to impact on uplift forces which are one of the four forces that apply to enable flight).
- 16. An industrial activity within the Rural 1 Zoning is also inconsistent with the objectives and policies of the TRMP which seeks to protect this land for activities related to the utilisation of the soil resource. The proposal is also inconsistent with the National Policy Statement on Highly Productive Land 2022 (NPS-2022). The subject land is LUC 1 and is captured by clause 3.5(7) given the rural zoning and the consent authority must avoid the inappropriate use or development of highly productive land (clause 3.9).
- 17. The proposed activity has been located on the site since 2021 (without the required resource consent) and has been subject to health and safety concerns in the past.
- 18. In October 2021, a crane was operating that was in breach of Civil Aviation Rules, Part 77 Objects and Activities Affecting Navigable Airspace (**Rules**). The Rules require notification to the Civil Aviation Authority (**CAA**) for a risk analysis of any intrusion into a 1:50 inclination (Rule 77.5(3)) and the 1:50 requirements defined within the TRMP (Rule 77.5(4)).
- 19. A second incident occurred on 14 April 2023 with the operation of a crane at a height of 12 metres. Tasman District Council issued a NOTAM (notice filed with the CAA to alert aircraft pilots of potential hazards along a flight route) under its obligations as the operator of the aerodrome, however, the notification obligations lie with the crane operator (Rule 77.5).

- 20. In addition, on 24 March 23 there was a request made to the submitter to use drones on the aerodrome to capture images of construction on the proposed site. The request detailed several flights to capture construction progress. The location of the site on the centreline, meant that the request could not be safely accommodated and permission was refused. This request highlights the tension of allowing a change of use to this site.
- 21. The submitter has erected one of the container structures on site. This was investigated by a compliance officer of Tasman District Council on 16 May 2023 and was discovered to extend some 7 metres in height in breach of Rule 77.5(3). The CAA has been notified of this failure to notify and the breach of CAA regulations.
- 22. The submitter considers that these past matters demonstrate the incompatibility of the activity in close proximity to the runway. The submitter is concerned that they also demonstrate a lack of awareness by Ruru management of the fundamental need to protect aircraft safety in this area.

### Risk

- 23. The RMA addresses any "potential effect of low probability which has high potential impact (s 3 RMA)" and this category of risk is relevant to the proposed activity. The proposed buildings are permanent structures. The applicant may also seek to undertake landscaping which may also present obstacles (such as the growth of trees). Moreover, the applicant proposes to have staff of around 60 people working from the site. The introduction of an industrial activity in close proximity to the runway introduces unnecessary and unwarranted risk to the operation of the aircraft in this area, the health and safety of people and property.
- 24. The immediate environment of the aerodrome is not uncomplicated at present. The aerodrome is contained by roads on two of its boundaries, the northeastern boundary along Queen Victoria Street being the most challenging area given the proximity of the runway. However, in the event larger aircraft need to land at the aerodrome, temporary traffic safety implementation measures can be introduced and the road could be shifted further away from the runway to meet this need in the future. The proposed activity adds a further complexity and risk into this environment which is not justified.

25. There is a new packhouse located to the north of the aerodrome, close to the applicant's site. The application sets out that the presence of the OLS influenced the placement and height of the proposed pack house building within the site, the use of land in the north-western corner for stormwater detention purposes and that it dictated the height to which bins may be stacked in the bin storage area (maximum of 3- 4 metres with the remainder of the site being up to 12- 16 metres) and any landscaping plantings along the frontage. As the proposed packhouse met all the requirements of Schedule 16.11A by not penetrating the 1:50 OLS, Motueka Aerodrome was not considered an affected party.

OLS 1:50

- 26. Rule 16.11.2.1 of the TRMP imposes an Airport Height Control (an inclination of 1:50 OLS through Schedule 16.11A) which applies to Motueka Airport. If any structure or vegetation exceeds the height limit of Schedule 16.11A a resource consent is required to authorise the activity under Rule 16.11.2.2.
- 27. It is possible that in the future there will be changes either to the extent and/or the angle of the OLS as the OLS is currently being reviewed. Any changes to the provisions of the TRMP will be subject to community consultation just as the initial provisions were. It is relevant to note that submissions to the TRMP sought the imposition of the Airport Height Controls to safeguard the operation of the aerodrome.
- 28. It is acknowledged that a 1:50 OLS is conservative, and for adjoining land use activities subject to the Airport Height Controls, this is restrictive. However, this needs to be seen in a context of the limited area subject to the Airport Height Controls and the Rural 1 Zoning which is inherently compatible with the controls given the limited range of permitted activities.
- 29. The submitter considers that it is prudent to maintain the OLS to its full extent until the review has been undertaken.
- 30. The 1:50 OLS provides an important buffer to protect the operation of the aerodrome. It is common for airport height controls to be stricter than CAA requirements in order to provide a buffer in other words, the restrictive airport height controls imposed through district planning serve to ensure safety

thresholds are not inadvertently crossed by placing strict controls to adjacent land use activities.

- 31. The submitter also considers that declining consent on the basis of noncompliance with the 1:50 OLS is justifiable to acknowledge the high use of the aerodrome by trainee pilots, to ensure full use of aviation technology such as GPS instrument approaches, the use of the aerodrome by larger aircraft, and night operations. For example, a Royal New Zealand Air Force Andover has landed at the aerodrome in the past and larger aircraft may be required in the event of an emergency.
- 32. Provided the exiting protections are retained, in an emergency situation the adjacent roads, Queen Victoria St and Green Lane, could be closed temporarily to allow full utilisation of available runway length. Without this protection emergency response capability will be reduced.

### Significant regional transport infrastructure

- 33. The application has not considered the implications of adopting a 1:20 OLS. It is stated that the proposal can comply with the 'operational 1:20 OLS.' However the adoption of this lower standard has implications for the operation of the aerodrome at present and also, more significantly, into the future. Fundamentally, the adoption of this lower standard is inconsistent the significant actual and potential role of the aerodrome as regional transport infrastructure.
- 34. It is also fundamental to maintaining a fully functional aerodrome without limitation to recognise the importance of the aerodrome for Civil Defence emergencies and as regional important infrastructure.
- 35. The aerodrome is important "backup" infrastructure of regional significance. There may be occasions in the future where Nelson Airport is unable to operate and therefore it is vitally important that there is an alternative runway location to accommodate a full range of aircraft. The proposed activity does not comply with the 1:50 OLS and therefore presents a risk to the future use for aircraft who need to be closer to the ground as they approach/land on the runway.

36. The aerodrome is an established activity providing significantly regional infrastructure whereas the applicant has a range of locations to choose to operate from, including industrially zoned land. The submitter considers that the decision maker should place greater weight on the operational needs of the aerodrome given its significance and adopt a conservative approach to decline consent the proposal as it does not comply with the 1:50 OLS.

### OLS 1:20

- 37. The submitter recognises that there are limitations in how it can operate and at present it operates to a 1:20 OLS. However, it can install one off or permanent traffic management measures to enable aircraft to be closer to the ground above Queen Victoria Street and/or it may be able to shift the road if future needs demand this. The addition of an industrial activity in close proximity would complicate any future development in this regard.
- 38. The applicant alleges that there is no penetration to the 1:20 OLS and therefore there is no health and safety risk as a result. However, consultation undertaken by the applicant has not included assessment of health and safety implications for aerodrome users. As a 'non-flying' participant in aerodrome operations, and as an entity with overlapping Health and Safety at Work Act 2015 duties with the aerodrome users, the submitter cannot unilaterally speak to the health and safety implications for aerodrome users.
- 39. The applicant alleges that there is no penetration to the 1:20 OLS and therefore there is no health and safety risk as a result. This contention is rejected by the submitter: the activity in itself presents a health and safety risk as the above paragraphs have highlighted, even if the 1:20 OLS inclination is not penetrated by any obstacle.
- 40. The CAA acknowledges the higher risk at take-off and approach by protecting the OLS through the Rules in Part 77. The CAA requires notification for any penetrations to a defined 1:50 OLS and compliance with the District Plan OLS definitions. Once notified, the CAA will conduct a risk assessment and request adequate measures are in place to mitigate any penetration to the OLS. If the OLS within the TRMP was relaxed, the 1:50 would remain applicable under Part 77, for the notification and risk assessment, due to the hazard of penetrations within the take-off and approach fan. The existence of the above

protocols emphasise that land-use at the end of a runway needs to be carefully regulated.

### Precedent

41. There is Rural 1 land adjacent to the site subject to the Airport Height Control controls which is currently used for agricultural purposes. The submitter is concerned that granting resource consent to an industrial activity in the Rural 1 Zone within the area subject to the Airport Height Control controls could create the expectation from others for like treatment, particularly given the availability of such land close to the Motueka township.

### **Decision sought**

- 42. The submitter seeks the following decision from the consent authority in order to ensure that any adverse impacts on the aerodrome are avoided:
  - that the resource consent application is declined; or
  - conditions are imposed to address the submitter's concerns raised in this submission.
- 43. The submitter wishes to be heard in support of its submission.
- 44. The submitter requests pursuant to s 100A(4) of the RMA that you delegate your functions, powers and duties to hear and decide the application to one or more hearing commissioners who are not members of the local authority.

### RM210785 - Land use consent to undertake an industrial activity in a Rural 1 Zone which is in breach of the airport height controls for the Motueka Aerodrome

This letter provides detail to the headings covered in our Submission on the Resource Consent Application.

### 1 Adverse impact on regional infrastructure

Motueka Aerodrome has been part of the regional aviation infrastructure for about 100 years. This allows small aircraft to operate around New Zealand. It helps connect Motueka and the surrounding area to the rest of New Zealand. In case of disaster or for search and rescue, the aerodrome allows rescue and other services to operate and reach nearby parts of New Zealand.

Recent experiences in the Hawkes Bay and East Coast attest to the fragility of the road (and rail) network in New Zealand. The Kaikoura earthquake also showed the importance of an aerial connection when other transport means were rendered unusable.

Predicted changes in the aviation area should also have implications for the future of the Motueka Aerodrome. In future, we are likely to see more aircraft built and powered in different ways (battery, hybrid, hydrogen, synthetic aviation fuel) flying New Zealand skies and connecting regional New Zealand in ways that currently, do not happen. Such changes are likely to require an enhanced range of services to be available at Motueka.

We also recognise the important role Motueka Aerodrome plays for some of our training members. Given the future demand for pilots in the Asia Pacific region, and the attempts being made to secure more of this training for New Zealand, it is reasonable to expect that Motueka Aerodrome will benefit from this increased demand to 'train in New Zealand'.

A fully operable aerodrome is, therefore, a strategic asset for Motueka.

### 2 Encroachment on existing uses

This is an issue in a number of areas in New Zealand. Aerodromes have been in place for around 100 years. Those looking to initiate developments near aerodromes must be responsible for ensuring that their activities will not impinge on the activities already carried out at the airport.

The Civil Aviation Authority provided useful guidelines for those looking to establish activities close to an aerodrome in its 2008 publication 'Guidance material for land use at or near aerodromes'. Civil Aviation Authority Rule Part 139.51 outlines requirements for registered airfields and it would be prudent for any developer near an existing aerodrome, to take this into account.

### 3 Safety and Risk

The request for a consent also results in a number of safety issues/considerations which impact adversely on the provision of 'safe flight' at the aerodrome. These include, but are not limited to:

- Health and Safety at Work (2015 Act) especially the reduction in safe runway length, the effect on glidescopes, crane activity and buildings in an area which pose greater threats to aircraft with an engine failure. The crash at Thames Airfield in August last year is a relevant consideration.
- **Existing operations** a shortened safe runway length will adversely affect safe operations at the Motueka Aerodrome for a number of existing aircraft types. Some aircraft will be unable to use the aerodrome.
- Future proofing the current asset the ongoing development of aviation will undoubtedly require different facilities. The risk is that by approving the consent, the District Council will be limiting its ability to participate in these developmental opportunities (adding additional capabilities).

For these reasons, we oppose the granting of the consent.

Kia ora,

Thank you for the opportunity to respond to application RM210785 by applicant Ruru Building Ltd.

Flying NZ is the umbrella organisation for over 44 Aero Clubs around New Zealand, one of which is the Motueka Aero Club who directly affected by this application.

Flying NZ is opposed to the breaching of the TRMP's OLS 1:50 gradient height protection on the approach and climb out from Motueka aerodrome in this application.

We request that you decline this application for the reasons stated below.

Our view is that allowing these buildings to breach the existing height restrictions will be detrimental to flight safety.

Safety will be compromised by reducing the margin for error during the critical take-off and approach phases of flight, where aircraft are particularly vulnerable to windshear and other forms of turbulence. Windshear (a sudden change in wind speed or direction), downdrafts and other turbulence can be induced by objects on the ground. The proposed buildings are close enough to create turbulence and sink for an aircraft lifting off, and as an aircraft passes overhead the margin for error is much less than there would've been without the buildings present.

Additionally, although unlikely, in the case of an engine failure after take-off, the presence of buildings occupying this space will severely limit a pilot's landing options and would not just increase the risk for the pilot and aircraft but also to the occupants of the building. If an aircraft has an engine failure after take-off at low altitude the options available to the pilot are limited. They are less able to turn and are generally committed to landing (more or less) straight ahead. At a distance further from the airfield this is less of an issue as a pilot has more height and ability to manoeuvre the aircraft into a clearer space.

While pilots are trained to correct for these situations, this proposal introduces additional, preventable, and predictable flight risk. It is worth noting that both Motueka Aero Club and Nelson Aviation College are training student pilots who are inherently less skilled at managing these critical phases of flight, and so this proposal particularly increases the risk to them.

We also note that the intrusion of the proposed buildings into the 1:50 approach protection may in future, cause difficulty in use of the airfield for night operations or the implementation of an instrument approach.

Flying NZ submits that the Council should make a strong effort to protect Motueka Aerodrome as a valuable asset with much future potential and to not let industrial requirements 'overgrow' the airfield.

To Whom It May Concern: My name is Alistair Hart I am a 787 pilot for Air New Zealand. I am also a qualified instructor for people wishing to obtain pilots licenses and I am rated to instruct on multiple types of aircraft. I am a member of the Motueka Aero club and have been using the Motueka runway for 41 years. I previously have owned and operated a flight training business on the Motueka aerodrome

The Motueka aerodrome is a public amenity similar to a road and other infrastructure in the area. In order for the aerodrome to operate successfully and safely it requires not only adequate runway length but also safe approach/departure angles to the runway. An approach/departure fan is an area at the start and end of a runway that angled upwards into the air, the idea behind this is that aircraft climb out and arrive above the bottom of the fan and objects and trees stay below the bottom of the fan. This is to allow for safe take offs and landings for aircraft operators and the community on the ground. Ruru Homes is proposing to build a tall structure within the fan and operate a tall crane. This poses major restrictions on the current and future use of the Motueka airport.

The construction of a tall building in the end of runway in the approach/departure fan will essentially shorten the runway therefore prevent the use of the runway for certain aircraft. For example air transport operations such as:

- Golden bay air using Piper/Britten Norman Islander/GippsAero Airvan
- Sounds air Cessna Caravan
- And other operators now and in the future

Not only does this impact its current users it also has the potential to stunt the growth the Motueka airport, limiting future job opportunities for the community.

The Motueka aerodrome is also a part of a safety network of airports, providing pilots with a place to land in the event of bad weather or mechanical problems.

The aerodrome in Motueka is a massive asset when it comes natural disasters and is a back up to the Nelson aerodrome. In fact the Motueka aerodrome was utilised extensively during the Takaka floods for transportation of goods and services when that community was cut off. Although it is not as large as the Nelson aerodrome it can still handle a wide number of specialised aircraft in an emergency such as those used by New Zealand Air force. The Motueka aerodrome is also utilised during search and rescue operations, providing a place to re fuel and for the teams to touch base with each other to plan and coordinate searches.

The Motueka Aerodrome is a public asset that needs to be protected for future generations. The airport cannot be moved but new structures need to be built sensibly in its environs.

A lack of due diligence and forward planning on the part of Ruru Homes has lead to a proposal of resource consent that will have a massive negative impact on the community if approved.

For these reasons I request that the Tasman District council declines the consent for this applications.
