1 April

 Met with Peter Bone and Steve Waring regarding a potential cycle trail in the region that would mimic the Otago Rail Trail. Peter is now in the process of forming a Trust to gain funding and move the idea forward, and I have since supplied a letter of support on behalf of the Council.

- Met with landowners in the Lee Valley regarding land issues associated with the Lee Valley Dam

 Attended the Saxton Field open session and briefing. I was again impressed by the tremendous opportunity that Saxton Field will give to our region and was challenged to consider how TDC and NCC will work together to manage this facility to maximise the benefit for the region.
