Mayor's Report for June/July 2009

I attended a meeting hosted by Bob Parker, Mayor of Christchurch, who explored the concept of a tourism initiative to brand the whole of the South Island as a destination for tourists. I found one conference workshop regarding comanagement of water issues particularly informative, highlighting the difference between management and governance when it comes to RMA planning and consent processes.
