There has been a lot of communication regarding amalgamation. One of the commonly asked questions is "what will this do to my rates?" Deputy Mayor Tim King has articulated this very well, and with my complete support, that while there are likely to be some savings, these have been exaggerated at times while the transitional costs have, at times, been ignored. In my view the honest answer is that the net benefit, if any, and the effect on rates, cannot be quantified. In my opinion the key issue for people to address is whether the proposal gives better representation.
