# RICHMOND

# MOUTERE – WAIMEA

## WAIMEA RIVER PARK DRAFT MANAGEMENT PLAN

Submissions on the above plan closed on 1 March with 37 submissions received. A number of the submitters have indicated that they wish to speak to their submission.

It is now necessary to appoint a hearing committee and set a date for the hearing. Three Councillors are required to form the hearing committee. The Chairman of Community Services Committee and a Councillor from each of the Richmond and Waimea Wards would be appropriate.
