#### 1. COMMUNITY GRANTS FROM RATES

Presenting the applications for 2011/2012 annual Community Grants to the Grants and Community Facilities Rate Subcommittee for consideration.

Grants are made to organisations whose services and projects provide wide community benefit and wellbeing in activities that are related to the objectives of Tasman District Council. Applications are made under the following categories.

- Community and Economic Development Initiatives
- Arts/Culture/Heritage
- Festivals and Events
- Youth/Children
- Social Services
- Beautification Schemes
- Emergency Services
- Community Newsletters
- Museums

The funding round has a total of \$174,000 available and this is made up of the annual allocation of \$164,000 plus the \$10,000 for Museums.

The current round closed on 31 August 2011 with 130 applications received requesting a total of \$331,000.

Applications will be considered on the following terms. Each Subcommittee member is required to consider and note the amount they recommend for each application.

- Meets the criteria of the scheme.
- Benefit to the community.
- Priority of the application.
- If supporting the application the amount of support suggested. Any conditions on granting support.

## 2. COMMUNITY CONSULTATION FUNDING

The Community Consultation grants are distributed for the purpose of providing funding assistance to ratepayer and community associations to assist consultation within their respective communities. There is a total of \$25,000 available.
