1. WAIMEA RURAL FIRE AUTHORITY

1.1 Principal Rural Fire Officer's Report for October 2011

The attached report covers a number of issues and notes that the large amount of rain during October has meant that fire permits have been able to be extended out to the end of November. Also of interest at the end of the report an update on the Australian National Fire Cadet Championships is given. These are the championships that the Brightwater Volunteer Rural Fire Force Cadets attended.

2. ASB AQUATIC AND FITNESS CENTRE

3. MAPUA COMMUNITY HALL

- 3.1 A letter has recently been received from the Mapua Community Hall Society advising that Graeme Stradling, who is the chairman of the project management team, will be their interim project manager through the planning sequence and building consent process.
- 3.2 The letter also advises that they are now at a stage where a resource management application and the relevant agreements have been developed and they shall be submitting this shortly. The Society is very conscious of the need to limit costs for their project and they are doing everything possible to keep within their budget.

- 4.1 At the last meeting I advised that the Motueka Rural Fire Party has a fire shed on leased land and that they were looking at options for relocating the building.
