SUBJECT: RESOURCE POLICY PROJECTS UPDATE REPORT - EP07/08/14

- Report Prepared for 23 August 2007 Meeting

1. PURPOSE OF REPORT

This report provides a six monthly update on the progress with current resource policy projects for the information of members.

2. BACKGROUND

The attached table describes the programme of projects for 2007 / 2008 and beyond, and covers process steps, current situation and next steps. As with previous reportings, it is open for the Committee to review or confirm projects' priorities or timings.

3. PROPOSED NEW PRIORITIES

Several new project priorities are put into the attached table for consideration by the Committee. These are:

- Golden Bay west settlement strategy
- Waimea estuary and catchment management strategy
- Rural futures: rural policy review

None of these projects has commenced, although they have a rationale from previous Committee decision-making. The Golden Bay west settlement review would follow from the planning work achieved in the eastern Golden Bay, and allow the challenging rural landscape and settlement pattern issues to be resolved for that pert of the District. The Waimea estuary management strategy is an opportunity to address wet and dry side issues in an integrated manner, with community participation, to refine the Plan's approach to estuary management in the largest one in the region. There is some community interest in this work. The rural policy review can only commence after operative plan (Part II) status, now expected in early 2008 following a scheduled late 2007 hearing of the outstanding productive land appeal.

Each of these projects was previously given a priority 2 ranking, for the relevant time period in which each was expected to commence. However, other priority project work and a finite staff resource have prevented their commencement before now. The Policy section will have staff time becoming progressively available later this year for reporting or workshopping on each of the projects, and seeking approval to

commence. This staff availability will still allow for all existing priority 1 projects currently under way, to continue in their terms.

In the table attached in relation to these projects, I have re-ranked their priority to a priority 1, to allow commencement of each following a scoping report for consideration either later this year, after the new term of Council commences, or for early in 2008. I seek agreement from the present Committee to allow staff to plan for this reporting for the new term of Council.

4. RECOMMENDATION

It is recommended that the Committee:

- **1. Receive** this report
- **2. Endorse** the proposed reprioritising for late 2007 onwards of three projects listed in the report
- **3. Recommend** the policy programme incorporating the revised priorities to the incoming Council later in 2007.
