## SUBJECT: REPORT ON DOG CONTROL POLICY AND PRACTICES REPORT EP07/09/10 - Report Prepared for 12 September 2007 Meeting

## 1. REASON FOR REPORT

The Dog Control Act Amendment Act 2003 now requires territorial authorities to publicly report on dog control policy and practices as outlined under Section 10a of the Dog Control Act 1996. This report contains information and statistics on Council's dog control activity for the year 1 July 2006 to 30 June 2007.

## 2. DOG CONTROL AND ENFORCEMENT PRACTICES IN TASMAN DISTRICT COUNCIL

Council's dog control activities are carried out by Control Services (Nelson) Ltd. Three full time dog control officers are employed by Control Services to administer Council's policy and practices throughout the Tasman District. Nine casual or parttime staff attend to the emergencies and/or after hours activities in the outlying areas of Murchison (three), Golden Bay (two), Motueka (two) and the Tapawera and Wakefield districts (two).

Control Services work closely with local veterinarians and have an excellent relationship with the three SPCA branches in the district. Good relations are also fostered between Dog Control and the Police and Dog Obedience Clubs.

Dog Control Officers also provide regular educational visits to local schools and organisations.

## 4. DOGS PROHIBITED, LEASH ONLY AND DOG EXERCISE AREAS

The Dog Control Bylaw 2004 sets out the areas in the District which are Dog Prohibited, Leash only and Dog Exercise Areas.

Council has received some comments from the community regarding the issues of dog control, beaches and birdlife.

A series of informative articles relating to dog control is being published in "Newsline", Council's fortnightly newsletter. These articles will serve to remind dog owners of their responsibilities.

## 5. DOG REGISTRATION AND OTHER FEES

The registration fees for dogs are set each year as part of the Council's Annual Plan Process. In 2006 / 2007 the registration fees were $\$ 35$ for Urban Dogs and $\$ 24$ for Rural Dogs which included the fees to cover the National Dog Database costs.
6. FURTHER COMMENTS ON DOG CONTROL MANAGEMENT

Council has received a large number of barking complaints which relate to two kennels, one being a boarding kennel and one a breeding kennel operating under a temporary licence. Council staff, as well as outside agencies have been involved with attempting to resolve these issues.

## 7. ANNUAL PROPERTY VISITS

Property visits continue to be conducted annually in residential areas and every two years in rural areas. These visits provide valuable contact with owners and the opportunity to educate and, in many cases, congratulate dog owners on their care and control of their dogs.

## 8. RECOMMENDATIONS

1. That this report required pursuant to Section 10A of the Dog Control Act 1996, be received and adopted by Council.
2. That the adopted report be publicly notified and be made available on the Council's website with a copy being sent to the Secretary for Local Government.
