PROGRAMME - EP08/05/05 - Report Prepared for 29 May 2008

Meeting

1. PURPOSE OF REPORT

This report provides a briefing on the current and likely situation with present and programmed resource policy planning projects and recommends reprioritising under current budget of some of these projects.

2. BACKGROUND

In November and December 2007 the Committee considered the resource policy programme and resolved to commence the Golden Bay west strategic development planning project and the Waimea estuary integrated management projects, at rates consistent with resourcing in the present budget but subject to any additional funding being proposed in the 2008/2009 annual plan. (Reports EP07/11/07 and EP07/12/04 refer). The review of the programme was in the context of the large number of active projects, and the constraints on resourcing, largely staff time.

The updated resource policy programme is attached with this report.

The following sections of this report consider a number of issues with this programme. There are emerging constraints on continuing to deliver across a number of projects, where the number of urban and rural strategic development planning workstreams are maturing into a growing number of plan change processes, many to be preceded by structure planning. In addition, through Court decisions, the Committee is now in a position to consider approving and making operative Parts I and II of the Tasman Resource Management Plan (Introductory and Land), but there are some implications of this move for Council's policy programme, as well as some difficulties with the plan change request opportunity that would follow.

These and other risks to the resource policy programme were flagged in December last.

3. STRATEGIC DEVELOPMENT PLANNING PROJECTS

In December 2007 I advised that the Golden Bay West, Waimea Estuary, and Brightwater and Wakefield could and should commence alongside existing projects. I noted the risks with capacity limits in the resource policy team, including the currently contracted professional services of Sonya Leusink-Sladen, with the rate of progress with maturing and additional numbers of strategic development planning projects. I also noted three further constraints:

- Availability of key staff in Engineering Services Department, and Community Services Department for all urban development projects particularly with the rollout of Richmond projects and corporate strategic projects (ESP review, stormwater management review)
- 2. Involvement of staff team members across all these departments with the programmed review of the LTCCP commencing beginning of 2008
- 3. The risk of significant numbers of private plan change requests being received after operative status of Part II TRMP.

There is now a number of strategic development planning projects, across Tasman and Golden Bays, with both pre-notification and post-notification phases current. The outlook is for more tightly structured timeframes as the work moves into and through the notification stage. This is the case for Richmond where there are four fronts of planning (south, west, central and east). A major reporting task is ahead for Variations 61 – 63 following further submissions. For Mapua-Ruby Bay, Motueka west, and east Golden Bay workstreams, structure planning is either the next step or a draft requires revision follow-through as instructions for the plan change stage. Workload pressures are acute immediately ahead for the affected staff team, as LTCCP work is occupying some time for key staff.

Principles applied in previous priority-setting situations by the Committee are:

- 1. Follow through on current projects to completion in terms of TRMP outputs
- 2. Do not start uncommitted projects until resource constraints allow it
- 3. Consider additional budgetary provision on the merits.

The decision options are to:

- 1. Allow progress to run as resources allow across the current project commitments
- Set relative priorities to give greater preference to some projects at the expense of others
- 3. Stop some projects and do not start others
- 4. Provide more policy planning resources.

All these projects have strategic drivers that are in general an expected need for urban development space, or risk of inappropriate development in high-valued locations. A common consideration for these strategic development projects, is the brake on achieving on-the-ground development opportunities caused by network servicing capacity constraints and the time horizons necessary before capital construction can unlock such land. The 2009 – 2019 LTCCP investigations and proposals for such timeframes to enable further settlement development are important in assessing geographic or other priorities. These are to roll out from the growth model review, activity management plans review and financial policy proposals, through this year.

My advice at this point is to adopt option 2 as directions to the Policy team, and to specify the broad relative priorities. When LTCCP infrastructure proposals are to hand, then a reappraisal of these might be efficient. My further advice is to give preference to completing those projects the most advanced, and depending on a decision on the issue reported on below, also continue to work across selected projects to complete the work necessary to the stage of notification. The selection needs to account for likely commitments in relation to appeals resolution: the most advanced projects in essence.

The key further consideration concerning project priorities, is the decision to be made concerning approval and making operative Parts I and II of the TRMP.

4. OPERATIVE PLAN ISSUES

We have sought legal advice to help in managing the process for achieving an operative version of Parts I and II provisions, both text and planning maps. The situation with live appeals and live variations complicates the process somewhat.

Despite the resolution of a key rural subdivision provision through the *Thoma* appeal being disposed of by the Court without any amendment to the TRMP, a large number of provisions that remain proposed and will need to be identified as "not yet approved" in this version. These arise from the live variations (14) and appeals (9).

The appeal topics are listed under Policy Project 1 in the updated programme table. The variation topics are:

Sections in the following chapters are affected by the live variations and appeals:

Chapters 2, 5, 6, 7, 8, 9, 13, 14, 16 (signs, transport, subdivision, hazardous facilities, 17 (all urban and rural zones), 18 (cultural heritage, land disturbance, coastal environment, slope instability special areas), 19 (information requirements for land and subdivision) zone maps (Richmond), area maps (all).

The RMA requires these live variations to be treated as proposed changes upon operative date, and the legal advice suggests packaging these changes (formerly variations) together with any subsequent proposed changes to the operative Parts I and II, separately from the operative version. This is because the operative provisions remain in place following further changes after operative date, where subsequent proposed changes may modify them. There is a weighting to be made between such proposed provisions and the operative ones, in relation to resource consents and compliance, as those future change provisions progress through the Schedule 1 process. To simplify this weighting, the current amendments by variation should be as advanced as possible (at least to appeal stage).

A further complication flowing from the pattern of "not yet approved" provisions is that the scope of private plan change requests to the operative version that may be received following operative date, may be limited because they may want to rely on amending provisions that are not yet operative. This could lead to both complexity and uncertainty in dealing with such requests.

Some of the proposed "holes" in the operative version of Parts I and II could be removed and incorporated in the version by pausing on approval and operative status, to allow resolution of the relevant appeal or variation to precede this move. There is a time pathway that can be defined to show the gains in consolidating the completeness of the operative version, against a time estimate of process required to remove such holes, by completing resolution of appeals. The following table shows the provisions affected, how, and the relevant timelines for resolution to be included in any operative version.

* Timelines:

- 1. Appeals resolution say by October 2008
- 2. Decision notification July 2008; appeals resolution say by early 2009
- 3. Hearings and decisions by October 2008, decisions notification November 2008, appeals resolution say by late 2009.

This information shows in simple terms, what any deferral of approval and operative status of Parts I and II over certain time horizons can lessen the extent of remaining proposed provisions. Any plan amendments being worked on under current projects over any such period, could be saved until operative status to be notified then as changes.

The earliest that an approval version can be assembled for becoming operative is July. This is because the text and map processing needed, at least to comply with

our legal advice, has been subject to modification by variations since 2006 when the intention to approve was first worked on. It would now be prudent to wait until the current cluster of variation decisions are notified, and appeals are known, before moving in this direction. This brings the minimum prudent time horizon to about September 2008.

From that point on, there is a weighing of advantages and disadvantages for then achieving approval and operative status. The following is a comparison of these across the three time horizons relevant to clusters of live Schedule 1 processes:

5. RECOMMENDATION

It is recommended that the Committee:

- Agree to pursue the present set of strategic development planning projects (option 2 in report), with priority to those most advanced (submissions processing and appeals resolution) so as to maximise the rate of resolution of contested rules in Part II
- 2. Agree to defer approval and operative Parts I and II until at least October 2008 to allow the further reduction of contested provisions and achieve further progress on strategic development work
- **3. Agree** to review the situation for both project priorities and operative plan by October 2008.
