PROGRAMME - EP09/07/12 - Report Prepared for meeting of

16 July 2009

1. PURPOSE OF REPORT

This report provides a briefing on the current and likely situation with present and programmed resource policy planning projects and recommends review of priorities under current budget for some of these projects not yet commenced.

2. BACKGROUND

In May 2008 the Committee last considered the resource policy programme (EP 08/05/02 refers). In the draft ten year plan (LTCCP) the following projects are listed as significant projects for the 2009/10 year. Since May 2008 the following key achievements with Committee approval have taken place:

- Live plan appeals stands at four (three cultural sites; one Richmond south) despite six lodged following decisions on Variations 55 – 59 (all these latter in course of being resolved by agreement)
- Parts I and II (Land) operative in part on 1 November 2008
- Richmond West DA Change 10 hearings complete and decisions in progress
- Draft Part IV (Rivers & Lakes) released for consultation
- Draft plan change cultural heritage sites released for consultation
- Water allocation reviews Moutere and Motueka catchments notified and submissions in.

Staff movements since May 2008 are:

- Sonya Leusink-Sladen re-commenced full-time since December 2008 but now on maternity leave and expected to not return
- Stephanie Trevena (part-time) resigned December 2008
- Lisa McGlinchey commenced (fulltime) end June 2009

The outlook is for further continuing a large number of priority projects. In particular, while not projects as such but rather administrative actions, the approval of the remaining parts of the Tasman Resource Management plan also remain milestones to achieve.

The aquaculture regime in Part III was approved some years ago but cannot commence until the AMA status is resolved. The remainder of the Regional Coastal Plan (rest of Part III, coastal discharges and water activities) is however able to be approved and a compilation is under action, to come shortly so that it may then be submitted to the Minister of Conservation for approval before commencing as operative. Similarly, Parts V and VI can be approved to become operative in part once compilations are to hand.

The updated resource policy programme is attached with this report.

3. PROJECTS FOR PRIORITY REVIEW

In May 2008 I noted the capacity limits in the resource policy team, with the rate of progress with maturing and additional numbers of strategic development planning projects. I also noted the constraints on progress through availability of key staff in Engineering Services Department, and Community Services Department for all urban development planning projects, particularly with the rollout of Richmond projects and corporate strategic projects (ten year plan, stormwater management review).

There is now a fair number of live strategic development planning projects, across Tasman and Golden Bays, with both pre-notification and post-notification phases current. The outlook is for more tightly structured timeframes as the workstreams move into and through the notification stage. This is the case for Richmond where there are four fronts of planning (south, west, central and east). For Mapua-Ruby Bay, Motueka west, and east Golden Bay workstreams, structure planning is either the next step or a draft structure plan requires revision follow-through as instructions for the plan change stage. For western Golden Bay, a consultation process on a number of issues is the next step before any draft plan change can be formulated.

Now that appeals on Change 8 (Eastern Golden Bay settlement policies) are resolving themselves, the momentum for the eastern Golden Bay work should be continued for the two planning fronts: Takaka, and Pohara –Tarakohe etc., to link with key infrastructure development (Port Tarakohe and new road link to Takaka) and additional residential land in both fronts.

Strategic development projects not yet commenced, with priority commitments from previous Council decisions, are the Brightwater and Wakefield projects; and a contractual commitment applies to progressing the Golden Bay work to a plan change by end 2009 for at least coastal landscape matters, and the same for Marahau to Kina for 2010. All these projects have strategic drivers that are in general an expected need for urban development space, or dealing with the risk of inappropriate development in high-valued locations. The difficulties with pursuing these projects are the cumulative demand by live projects on other departmental services especially the network asset managers, and the current policy staff commitments in advanced projects.

Other longstanding priority work includes the rural policy review, with work having been deferred for over three years pending the operative plan. Currently with staff committed in urban strategic work, there is limited scope to commence this project for some months. Cleanup of a limited change on coastal land disturbance (Change 3) has my time implicated, and Change 4 on transport standards requires Richmond west work to be completed and project stormwater ESP review work for it to be moved along. This latter area demands time from the asset managers.

Principles applied in previous priority-setting situations by the Committee are:

- 1. Follow through on current projects to completion in terms of TRMP outputs
- 2. Do not start uncommitted projects until resource constraints allow it
- 3. Consider additional budgetary provision on the merits.

The 2009/2010 budget is set; my advice is to give preference to completing those projects the most advanced, and to confirm selected projects to complete the work necessary to the stage of notification. The selection needs to account for current commitments, and more detail can be provided at the meeting.

4. RECOMMENDATION

It is recommended that the Committee **review** or **confirm** the priority status of projects in the updated programme.
