SUBJECT: RESOURCE POLICY PROGRAMME UPDATE - REPORT

REP10-12-11 - Report prepared for meeting of 16 December 2010

1. PURPOSE OF REPORT

This report provides an updated resource policy programme description and briefing on the current and likely situation with present and programmed projects.

2. BACKGROUND

In July 2010 the Committee last considered the resource policy programme (EP 0/06/02 refers). Since July 2010 the following key achievements have taken place:

- Changes 5 & 11 (Richmond South), 6 (Coastal Tasman DG), 7 (stormwater management), 8 (Eastern GB settlement policies) and 9 (landscape policies) approved and operative
- Draft Change 22 Mapua Ruby Bay development prepared and further work on subdivision options for EPC
- Draft change for Motueka west & central prepared for EPC
- Changes 20 (Richmond East), 21 (fault rupture risk management), and Variation 71 (slope instability risk area review, Richmond) notified and submissions all in
- Submissions all in for Plan Change 16 on cultural heritage sites management
- Submissions all in for Proposed Part IV (Rivers & Lakes) as package of variations and a change notified December 2009
- Appeals mediation on water allocation reviews Moutere and Motueka with two
 of three appeals settling
- Appeals (2) on Change 14 frost devices mediated

- Takaka South Takaka: Takaka floodplain modelling and risk assessment completed (workshop with Councillors expected in the New Year).
- Golden Bay landscapes change at issues and options engagement for report to Environment & Planning Committee in early 2011
- Plan amendments for aquaculture in Aquaculture Legislation Amendments bill (No 3) following collaboration between staff and Government officials.
- Submissions on various national standards (contaminated sites, plantation forestry) and Nelson plan (Change 18 Nelson south).

The outlook for the rest of 2010 and beyond is for further progress on a large number of live priority 1 projects. These are shown in the updated resource policy programme appended to this report. The programme update codes the life-cycle status of all projects (approval to start, live, paused, ongoing); completed projects are no longer shown.

3. PRIORITY PROJECTS

We continue with a large number of high priority (priority 1) projects. Projected staff time budgets within the resource policy section form July 2010 onwards have increased over the previous year. The availability of key staff and capacity for related investigations work in other departments, on which policy planning work progress also relies, mean that Council is able to take up new projects ahead, only when key milestones with live projects are reached. This is because:

- Staff effort is not continuous on live projects (eg. other players such as community stakeholders are providing feedback) and so staff can work on several projects at the same time
- A number of Plan amendment projects have moved into the proposed stage with reporting work able to be staged because of submissions periods
- Individual staff have special areas for policy planning work and are best used in teams to apply their knowledge and skills
- Additional time resources have been made available.

In July 2010 priority adjustments were:

- Brightwater and Wakefield projects (approval to start): confirmed as priority 1 and to be scoped for commencement in 2011
- Eastern Golden Bay for the Pohara Tata urban area (approval to start): moved from priority 1 to 2 (drivers are Port Tarakohe development and infrastructure links, and dealing with lifestyle development demand in a visible and sensitive coastal landscape more strategically than historical planning decisions from the 1990s)
- Rural policy review (approval to start): moved from priority 1 to 2 (drivers are need to review effectiveness of zones and rules to protect highly productive land and deal with residential and business developments in rural areas; deferred for nearly four years)

 Fate of Tasman RPS (not started; priority 2): agreement to combine with TRMP and defer start until late 2011 (drivers are RMA review, combination opportunity, need for reviewed section on Maori significant issues via lwi environmental management plan support)

In addition to the programme, there are additional live projects as interdepartmental projects that require time of Resource Policy staff. These are:

- Urban stormwater management.
- Richmond central area development plan.
- Growth model review.

These will have peak needs in the first part of 2011.

In summary, between the current live projects and the Resource Policy section's progress with them, there is some limited capacity to have the Committee consider and approve the start of some new projects, identified in the programme and deferred for some time. The team is however close to the limit of what is required for effective management of the work programme.

Options for the Committee to direct on the resource policy programme are:

- 1. Allow continuation of current programme with no new projects
- 2. Direct the pausing of some live projects allow to others to progress or start
- 3. Allow new projects to start only after key live projects have passed milestones.

The first option is inefficient as there will be some additional capacity through 2011 and beyond. The second option redirects staff onto other priorities: while this is possible there are reorientation inefficiencies and stakeholders may not like this pause. The third option can take up some limited capacity increase in relation to urban environment planning but should be tuned to happen only after progress in key current projects. It is recommended that all new projects be approved to start by the Committee's considering a scoping paper, with resourcing implications and advice at the time.

4. RECOMMENDATION

It is recommended that the Committee:

- 1. **Note** the priority 1 project commitments for 2010/11and the need and capacity to allow the start of limited new projects
- 2. **Agree** that approval to start any new project be resolved after considering a scoping paper for the project

3. **Agree** to receive scoping papers in early 2011 for Brightwater and Wakefield development reviews and rural policy review, but not commence any of these projects until Richmond East (Change 20) is heard and decided and changes notified for Mapua-Ruby Bay, Motueka west & central, and Golden Bay landscapes.
