1. LEGISLATIVE CHANGES

Submissions have been lodged on the following statute amendments which the Government has released in recent months and which will impact on local government environment and planning business:

Alcohol Law Reform (submissions closed 18 February 2011)
Aquaculture Law Reform (submissions closed 11 February 2011)
Biosecurity Act Amendment (submissions closed 10 February 2011)

3. PROPOSED NATIONAL POLICY STATEMENT ON BIODIVERSITY

The Government has released for submissions a proposed National Policy Statement on Biodiversity. The proposed NPS is intended to provide clearer direction to local authorities on their responsibilities for managing indigenous biodiversity under the Resource Management Act 1991. It outlines policies and decision-making frameworks for the identification and management of indigenous biodiversity found outside the public conservation estate.

The proposed NPS contains a list of criteria for identifying areas of indigenous vegetation and habitats of indigenous animals that have been recognised as being rare and/or threatened at a national level. These criteria are based on the Government's Statement of National Priorities for Protecting Rare and Threatened Biodiversity on Private Land. The proposed NPS requires district and regional plans

to identify these areas of significant biodiversity within five years of the NPS taking effect. This potentially cuts across the work we have done with land owners and the Tasman Biodiversity Forum. We may need to use the "where practical" opt-out.

Local authorities would be required to manage the effects of activities through district and regional plans and resource consent decisions (or be satisfied that effects are managed by other methods) to ensure there is no net loss of significant indigenous biodiversity.

Submissions close on 2 May 2011. A presentation will have been in Richmond on 3 March. Staff will prepare a submission.

4. WATER RATIONING

As at time of writing, we have, after two days, removed Stage 1 restrictions from the Motupiko catchment. Restrictions have also come off in Golden bay because of the rain but Stage 1 restrictions remain in place for the Waimea Plains. I will give an update at the meeting.

5. CHRISTCHURCH EARTHQUAKE

Environment and Planning staff have been deployed to help with the recovery phase following the 22 February earthquake in Christchurch. Hopefully those who remain will have the capacity to maintain services to Tasman customers but if there are issues we will keep customers informed.

6. RECOMMENDATION

It is recommended that this report REP11-03-08 be received.



Vector Operations summary to date:

- Six output ground control operation and associated performance monitors have been completed.
- Three ground control operations are in progress.
- Five trend monitors have been completed and eleven remain to be completed in February/March 2011.

3. 2010/11 TENDER ROUNDS

84% of the ground control contracts tendered for the period between January and June 2011 have been accepted by local contractors, with 16% of the contracts still in negotiation; all associated performance monitors have been awarded and accepted by local contractors.

Two additional trend monitors have been approved for East Takaka Brooklyn and Golden Bay; these will be tendered in February 2011.
