## 1. Purpose

1.1 To approve the 2011/2012 Tasman Bays Heritage Trust Statement of Intent (SOI) and strategic plan, for signing.

# 2. Background

- 2.1 Tasman Bays Heritage Trust (TBHT), along with other Council-controlled organisations, is required to complete a SOI by 30 June each year.
- 2.2 Representatives of TBHT were in attendance at the 29 July 2011 Joint Shareholders Committee meeting to provide clarification and answer questions.
- 2.3 Following discussion, the following resolution was passed:

  "That the Tasman Bays Heritage Trust Draft Statement of Intent and Strategic Plan for 2011 2012 be approved for signing."

## 3. Options

- 3.1 Accept the Statement of Intent as presented, subject to a similar resolution being passed by Nelson City Council.
